- Section 50.4.1.E of the Subdivision Regulations generally states that Preliminary Plans must be scheduled for a public hearing within 120 days after the date an application is accepted.
- The Application was accepted on June 15, 2022, which established a Planning Board date no later than October 13, 2022. On September 8, 2022, the Planning Board approved the first extension until January 11, 2023. On January 5, 2023, the Planning Board approved the second extension until April 11, 2023. On March 30, 2023, the Planning Board approved the third extension until July 11, 2023. On July 11, 2023, the Planning Director approved the fourth extension request until August 11, 2023.
- The Applicant is now requesting the final extension for a period of one month until September 11, 2023, which will provide sufficient time for the Applicant to obtain approval letters from the reviewing agencies as a result of significant site layout revisions including the well and septic systems.
- The Application is scheduled on the Planning Board's agenda for September 7, 2023.
- Staff supports the Applicant's request to extend the review period through September 11, 2023.
