# Summary

- Section 50.4.1.E of the Subdivision Regulations generally states that Preliminary Plans applications must be scheduled for a public hearing within 120 days after the date an application is accepted.
- Application for Preliminary Plan Amendment No. 11999100B was accepted on June 14, 2023, which established a Planning Board date no later than October 12, 2023.
- The Applicant is requesting a two-month extension until December 21, 2023, to allow additional time to address comments from various agencies including Fire and Rescue access, transportation, and the site layout. Issues being addressed include inter-parcel connections with adjoining properties, adequate access for emergency vehicles, parking configuration, and sidepath connections.
- Staff recommends APPROVAL of the extension request.
