#### **Description**

Second request to extend the regulatory review period for the Loehmann's Plaza Sketch Plan from October 26, 2023, through November 30, 2023. The Application seeks to implement infill development with up to 710,000 square feet of residential uses and up to 40,000 square feet of commercial uses for a cumulative density of up to 750,000 square feet of mixed-use development, with 15% Moderately Priced Dwelling Units (MPDUs), open space, pedestrian and bicycle improvements, and associated public benefits to support incentive density.

## Summary

- Section 59.7.3.3.C of the Zoning Ordinance provides a 90day review period for Sketch Plan hearings. The Planning Board may, however, extend this period.
- On August 8, 2023, the Applicant requested a 30-day extension of the regulatory review period, which was approved by the Planning Director on August 9, 2023 from September 26 through October 26, 2023.
- This is the second extension request associated with the subject project.
- The Applicant has requested, in an application dated September 19, 2023, that the review period for the Sketch Plan be extended by two (2) weeks from October 26, 2023 to November 9, 2023. However, Staff recommends the Planning Board extend this request by 30 days in case of unforeseen circumstances in scheduling the hearing.
- This extension will allow the Applicant to continue to work with Planning Staff and the Montgomery County Department of Transportation (MCDOT), to adequately address a variety of Development Review Committee (DRC) comments.
- Key issues that require additional agency coordination include: (1) refinement of proposed new roadways; (2) refinement of the proposed public benefit points for incentive density; (3) requirements for open space; and (4) phasing.
- Staff recommends APPROVAL of the extension request through November 30, 2023.
- The Planning Board hearing on the application may take place before the end of the review period, with a tentative Planning Board date of November 9, 2023, and will be publicly noticed in accordance with the Zoning Ordinance.
