

## 🖹 Summary:

- Section 50.4.1.E of the Subdivision Regulations
   provides a 120-day review period for Preliminary
   Plan. The Planning Board may, however, extend this
   period.
- The Preliminary Plan Application was accepted on May 30, 2023, establishing a Planning Board approval date no later than September 28, 2023.
- The Director approved one extension for this Application extending the review period to October 26, 2023.
- The Applicant is requesting that the review period for the Preliminary Plan be extended three months from October 26, 2023 to January 18, 2024.
- This extension will allow the Applicant time to resolve storm drainage and storm water management concept issues with the Department of Transportation and the Department of Permitting Services.
- The Planning Board hearing on the application may take place before the end of the review period and will be publicly noticed in accordance with the Zoning Ordinance.
- Staff recommends APPROVAL of the extension request.
