

🖹 Summary

- Section 59.7.3.4.C provides a 120-day review period for Site Plan hearings. The Planning Board may, however, extend this period.
- The Application was accepted on August 30, 2023, which established a Planning Board date no later than November 30, 2023. The Applicant was granted a 30-day extension by the Planning Director, establishing a new Planning Board date not later than December 28, 2023.
- The Applicant is requesting an additional 2-month extension of the review period to February 26, 2024. (Attachment A)
- This extension will allow the Applicant time to request and process a parking waiver for the subject application. The overall Milestone Shopping Center is overparked, however the Walmart property as an individual site will be under parked by 8 spaces with the proposed Amendment.
- The Planning Board hearing on the application may take place before the end of the review period and will be publicly noticed in accordance with the Zoning Ordinance.
- Staff recommends APPROVAL of the extension request.
