Chapter 50, 59, and 22A

Summary:

- Section 50.4.1.E of the Subdivision Regulations provides a 120-day review period for Preliminary Plan. The Planning Board may, however, extend this period.
- The Preliminary Plan Application was accepted on May 30, 2023, establishing a Planning Board approval date no later than September 28, 2023. The Planning Director approved an extension for this Application until October 26, 2023. The Planning Board approved a second extension for this Application, extending the review period to January 18, 2024.
- The Applicant is requesting that the review period for the Preliminary Plan be extended three months from January 18, 2024 to April 18, 2024.
- This extension will allow the Applicant time to obtain an approved storm water management concept from MCDPS-SWM.
- The Planning Board hearing on the application may take place before the end of the review period and will be publicly noticed in accordance with the Zoning Ordinance.
- Staff recommends APPROVAL of the extension request.
