The Greater Goshen Civic Association Board has reviewed the plans and have the following questions:

- 1) Will the traffic signal have cameras? There is no enforcement on this road by either the Gaithersburg or Germantown police departments because the road is too dangerous for them to pull over offenders and as a result there is constant racing in both directions from the three way stop at the park.
- 2) We were told during a presentation to UCAB by Dan Sheridan that the new bridge would have sidewalks to accommodate the shoulder parking on Brink towards Blunt? That does not appear on the plans.
- 3) The county owns land for parking in this area, why are you not utilizing that?
- 4) The draft plan and noise study plan appear to be based on studies done in 2015? Is that correct?
