

## SUMMARY

- Transportation funding in the County Executive's Recommended FY25 Capital Budget and sixyear CIP will be reduced by four % compared to the Approved FY23-28 Capital Improvement Program (CIP).
- The advancement of two major Bus Rapid Transit projects for MD 355 Central and Veirs Mill Road continue to be major project priorities in this Recommended Capital Budget for transportation.
- Increased funding and schedule acceleration is recommended for the US 29 Pedestrian and Bicycle Improvement Project.

## **RECOMMENDATIONS SUMMARY**

- US 29 Pedestrian and Bicycle Improvements (P502304): Increased project funding and an accelerated project schedule should be considered for this project. The current scope of proposed improvements is insufficient to adequately address pedestrian and bicycle needs along the US 29 corridor. As identified in the Bicycle Master Plan Biennial Monitoring Report, potential bikeway connections to the US 29 corridor could be enhanced with the addition of two projects:
  - Castle Boulevard connecting to existing bikeways on Briggs Chaney Road and to the US 29 FLASH station, and
  - **Tech Road/Broadbirch Drive** providing connections to the US 29 FLASH station, Adventist Hospital and the future Viva White Oak development.
- **Montgomery Village Avenue Bikeway:** Design and construct the master-planned bikeway on Montgomery Village Avenue north of the Gaithersburg City line to provide synergies with the coming redevelopment of Lakeforest Mall.
- **Bicycle Parking at Public Schools:** Over the next two years, prioritize funding to upgrade bicycle parking at the following schools: Dr. Ronald A. McNair ES, Glenallen ES, Bells Mills ES, Poolesville ES, Sligo Creek ES, Olney ES, Thomas W. Pyle MS, Silver Spring International MS, North Bethesda MS, Rosa M. Parks MS, Westland MS, Bethesda-Chevy Chase HS, Quince Orchard HS, Walt Whitman HS, and Walter Johnson HS.
- **Systemic Safety Countermeasure Program**: Initiate a funding program focused on systemic improvements that address crash risks identified in the Predictive Safety Analysis.
- **Bicycle Parking Stations:** Fund a bicycle parking station at the Glenmont Metrorail station.
- **Aspen Hill Bicycle-Pedestrian Priority Area project:** Fund a new project to implement the safety recommendations in the Aspen Hill Vision Zero Study.
- **Protected Crossing Spacing:** Continued or increased funding support for the Traffic Signals project (CIP Project No P507154) is needed for the design and construction of more protected crossings to fill in the gaps in the protected crossing network, including those identified in Table 7 of the 2023 Travel Monitoring Report.
- **Grid of Streets:** Continued support is needed to advance projects in the capital budget to build out the street grid, including:
  - North High Street Extended (CIP Project No. P502310) in Olney
  - Summit Avenue Extension (CIP Project No. P502311) in Kensington

## INTRODUCTION

The County Executive published his Recommended FY25 Capital Budget and the FY25-30 Capital Improvements Program (CIP) on January 16, 2024. The memo from the County Executive detailing the recommended budget changes is located at:

This staff report analyzes the recommended budget for transportation projects. It notes projects that have significant changes in budget or in schedule, including projects that are important to the fulfillment of adopted master plans and projects that are identified as part of the biennial Travel Monitoring Report.

The Planning Board is asked to review staff comments on the capital budget and CIP and transmit them to the County Council. Staff recommendations are provided in detail on page 13.

## SUMMARY OF THE COUNTY EXECUTIVE'S RECOMMENDED CIP


In the spring of even-numbered calendar years, the County Council adopts a Six-year Capital Improvements Program (CIP). In the spring of odd-numbered years, the Council considers amendments to the adopted CIP. The current CIP runs from FY25 through FY30.

On January 16, 2024, County Executive Marc Elrich released his recommended FY25 Capital Budget and FY25-30 CIP for the County Council's consideration. As shown below in Table 1, the recommended FY25-30 CIP funding totals \$5.8 billion, with 25.1 percent (approximately \$1.7 billion) allocated for transportation projects. Compared to the previous CIP, the recommended six-year transportation funding would decrease by \$72.24 million (a 4.0 % decrease).

A summary of the transportation CIP by improvement category is shown below in Figure 1. In the recommended funding in the six-year CIP, Mass Transit has the highest share of the transportation budget (35 percent), followed by Pedestrian Facilities/Bikeways (17 percent), and Highway Maintenance (17 percent).

## MAJOR CHANGES IN THE COUNTY EXECUTIVE'S RECOMMENDED TRANSPORTATION CIP

Compared to the amended FY23-28 CIP, the County Executive has recommended a FY25-30 six-year CIP with transportation project funding that is \$72 million less than the approved FY23-28 CIP (4.0 percent reduction). Table 2 below highlights these changes in funding by project category. This includes modest increases (between two and six percent) in funding for Bridges, Highway Maintenance, Mass Transit (MCG), Parking, and Traffic Improvement projects. In contrast there was a 77.6 percent decrease in funding for Roads, and a 17.9 percent decrease in funding for Pedestrian Facilities/Bikeways.

Transportation projects with significant changes in funding allocations are included in Table 3, Table 4, and Table 5 below. As shown in Table 3, the existing Capital Crescent Trail project will be closed out after FY27. Projects showing decreased funding in the six-year CIP include Observation Drive Extended, Summit Avenue Extension, Bradley Boulevard Improvements, and the Bridge Renovations level of effort project.

As shown in Table 4, six projects have significant increased funding in the recommended CIP, including the Ride On Bus Fleet, the Falls Road Bikeway and Pedestrian Facility, the Bowie Mill Road Bikeway, Fenton Street Cycletrack, the Ride on Fare Equipment replacement project and the Forest

Glen Passageway project. With this recommended CIP, the Fenton Street Cycletrack is anticipated to be completed by FY26, the Bowie Mill Bikeway is anticipated to be completed by FY29, and the Falls Road project and the Forest Glen Passageway are both anticipated to be completed by FY30.

There are five projects with significant recommended funding changes that would result in funding being shifted beyond the current 6-Year CIP. These recommendations remove \$86.8 million from the 6-year CIP and place \$172.7 million in project funding beyond the CIP, including the \$82.5 million for the Capital Crescent Trail Tunnel, \$4.03 million for Observation Drive Extended, \$12.5 million for the Summit Avenue Extension, \$17.3 million for the Bradley Boulevard improvements, and \$17.4 million for the Tuckerman Lane Sidewalk. These changes are highlighted in Table 5.

The County Executive's recommended CIP includes ten new transportation projects. Of note, a new project number has been created for the Capital Crescent Trail Tunnel (P502512) to provide different budget and scheduling allocations than the current Capital Crescent Trail project number (P501316). Clearly, this is being done to distinguish between remaining Capital Crescent Trail activities now committed for FY25-27 as part of the Purple Line project and future efforts to construct the Capital Crescent Trail Tunnel improvements that are now not covered in the Recommended CIP. With this recommended CIP, most funding for the Capital Crescent Trail Tunnel has been moved to beyond the six-year CIP. Three bridge projects have been added to respond to needed bridge improvements or replacements, a secure bike parking facility project has been added for Silver Spring and Bethesda, and several parking security camera surveillance system projects have been added in Bethesda, Silver Spring and Wheaton. The new projects are shown below in Table 6. Note that the Planning Board recently reviewed the Redland Road Bridge project as a mandatory referral.

## ANALYSIS OF RECOMMENDED TRANSPORTATION CIP

Every two years, the Planning Board transmits its county transportation funding priorities to the County Executive during the Executive's preparation of the CIP. The priorities are general based on master plan recommendations and a project's potential impacts on equity and Vision Zero safety efforts. The most recent list of county transportation priorities was approved by the Planning Board on July 27, 2023 and transmitted to the County Executive on July 31, 2023 (see Attachment A).

Following is a summary of notable CIP projects that have been reviewed in relation to the Planning Board transportation priorities and in advancing master plan and other Planning Department concerns/initiatives. These include a review of:

- Major Transportation Projects in the Planning Board's Priority List
- Major Transportation Projects Not in the Planning Board's Priority List
- Major Project-Related Concerns Not Addressed in the CIP
- Additional Master Plan Issues Not Addressed in the CIP

## MAJOR TRANSPORTATION PROJECTS IN THE PLANNING BOARD'S PRIORITY LIST

The following is a discussion of the County Executive's recommended changes to key transportation CIP projects included in the Planning Board's priority list:

- **Bus Rapid Transit: MD 355 Central (P502005):** This project has only changed slightly in the identification of funding sources. This bus rapid transit project is proposed on MD 355 between Rockville and Germantown. With the recommended FY25-30 CIP, \$413.3 million is budgeted for this project. The bulk of the funding for this project is expected to come from two sources: 1) federal aid (\$204.4 million), and 2) Op Lanes (formerly the I-495/I-270 Managed Lanes project) Maryland Transit funding (\$167.7 million). Additional funding for this project includes current revenue, transportation impact taxes, state aid (\$47.7 million), and recordation tax premium funds. The MD 355 Central BRT project was identified as the top overall transportation CIP priority by the Planning Board.
- **Bus Rapid Transit: Veirs Mill Road (P501913):** The budget for this project has only changed slightly in the identification of the funding sources. This bus rapid transit project proposed between Downtown Wheaton and Montgomery College Rockville will complete Final Design in FY24 and be fully constructed by FY27. Funding sources for this project include current revenue, transportation impact taxes, federal aid (\$99.4 million), state aid (\$23.9 million), and a new state bus rapid transit fund (\$28.8 million). This project was identified as the #2 overall transportation CIP priority by the Planning Board. It is important to note that this project will construct an interim project that will operate in traffic for a substantial portion of the corridor and that the intent is to upgrade the BRT to dedicated transit lanes for the full length of the corridor, as recommended in the 2019 *Veirs Mill Corridor Master Plan*, as part of a future, unfunded project.
- **Capital Crescent Trail Tunnel (P502512):** A new project number was created for the Capital Crescent Trail Tunnel project, and all funds have been recommended beyond the six-year CIP. This funding is needed to complete the Capital Crescent Trail tunnel under Wisconsin Avenue and improvements at Elm Street Park to build out the master plan vision to coincide with the opening of the Purple Line (FY27). Beyond FY30, a total of \$82.5 million is allocated to complete this project. This project was identified by the Planning Board as overall transportation CIP priority #6.
- Forest Glen Passageway (P501911): The overall budget for this project has increased by \$3.9 million. With the recommended six-year CIP, this project has been delayed by two years. In the previous CIP, construction was anticipated to begin in FY26 and be completed by FY28. Construction completion is now anticipated in FY30. This project will be funded with GO

bonds. This project was identified as overall transportation CIP priority #10 by the Planning Board.

- North Bethesda Metro Station Northern Entrance (P501914): The project is now scheduled to start construction in FY27 with \$8.1 million in county funds. The total project is currently estimated at approximately \$35 million. The remaining funds will be solicited from WMATA, MDOT, and developer contributions. It is expected that WMATA will select a development partner and initiate design in FY24 and will be ready to commence construction in FY26. This project was identified by the Planning Board as transportation CIP Transit priority #6.
- Fenton Street Cycle track (P502001): There has been no change to the funding for this bike project in Downtown Silver Spring on Fenton Street between Planning Place and King Street. This project, which is anticipated to be constructed by FY26, was identified as transportation CIP bicycle priority #7 by the Planning Board.
- **Observation Drive Extended (P501507):** The six-year CIP for this project is proposed to be decreased by \$56.7 million and the construction completion has shifted back beyond FY30. Phase 1 is the connection of Observation Drive between Waters Discovery Lane and Little Seneca Parkway and the completion/improvement of Little Seneca Parkway between MD 355 and Observation Drive. Phase 2 is the future extension of Observation Drive up to the future Clarksburg Bypass/Roberts Tavern Road. This project (Phase 1 only) was identified by the Planning Board as the transportation CIP road priority #3. Delays in this overall project are aligned with the ongoing Clarksburg Gateway Sector Plan.

#### MAJOR TRANSPORTATION PROJECTS NOT IN THE PLANNING BOARD'S PRIORITY LIST

There are many notable transportation projects included in the County Executive's recommended CIP that Planning staff is generally supportive of, and while they did not make the Planning Board's top priorities, they are worthwhile efforts. These projects include ongoing level-of-effort work programs, cost sharing for Maryland Department of Transportation – State Highway Administration (MDOT SHA) projects, first mile/last mile transit-supportive programs as well as some notable older projects that have already advanced through Mandatory Referral.

- **Falls Road East Side Hiker/Biker Path (P500905):** This project is proposed to be constructed by FY30. This project has been deferred repeatedly over the past 20+ years.
- **Bowie Mill Road Bikeway (P502108):** With the recommended CIP, this \$9.6 million project is now proposed to be completed by FY29.
- US 29 Pedestrian and Bicycle Improvements (P502304): \$7.9 million is budgeted for this project to fund the design and construction of pedestrian and bicycle improvements to Flash stations along the US 29 corridor. With the recommended CIP, these improvements would be fully implemented by FY30. This project was reviewed by the Planning Board during the review of the US 20 BRT Phase 2 project last year, and the need for more funds and an accelerated

schedule was identified at that time. The current scope of proposed improvements does not do enough to adequately address pedestrian and bicycle needs along the US 29 corridor.

- **Oak Drive/ MD 27 Sidewalk (P501908):** \$15.1 million is budgeted for this sidewalk project. The project would be fully constructed by FY28 with this recommended allocation.
- **Goldsboro Road Sidewalk and Bikeway (P501917):** \$21.1 million is budgeted to complete this project, yet no funds are budgeted for this project in the six-year CIP. The previous CIP committed some funds in FY26 through FY28.
- **Bradley Boulevard (MD 191) Improvements (P501733):** \$17.3 million is proposed to be delayed beyond the 6-year CIP for this bikeway project. Construction was scheduled to begin in FY26 and be completed in FY27, but now the project will begin construction sometime after FY30.
- Metropolitan Branch Trail (P501110): This project's CIP funding has increased by \$202,000. This project was previously one of the Planning Board's top transportation priorities. Since it is now fully funded, it was removed from the transportation priority list. Phase 1 construction was completed in 2018. Phase 2 design and property acquisition was completed in FY22. Utility relocations were completed in FY22. Construction was scheduled to start in FY22 and be completed in 30 months (FY24). Due to bid procurement rules, the project was re-bid and is now anticipated by be complete by FY26.

#### MAJOR PROJECT-RELATED CONCERNS NOT ADDRESSED IN THE CIP

- **Bikeways in Equity Focus Areas:** Advancement of the following three master planned bicycle projects will improving connections in Equity Focus Areas:
  - 1) Montgomery Village Avenue providing synergies with the coming redevelopment of Lakeforest Mall,
  - 2) Castle Boulevard connecting to existing bikeways on Briggs Chaney Road and to the US 29 FLASH station, and
  - 3) Tech Road/Broadbirch Drive providing connections to the US 29 FLASH station, Adventist Hospital and the future Viva White Oak development.
- Systemic Safety Countermeasure Program: Initiate a funding program focused on systemic improvements that address crash risks identified in the Predictive Safety Analysis. Systemic countermeasure implementation is a common Vision Zero approach that identifies many locations throughout the county for rapid application of improvements. These treatments are generally considered well-suited for widespread implementation because of their safety effectiveness, cost effectiveness, and because they may be implemented with limited study and design. In contrast, spot safety treatments use traditional site-based analysis at a specific

location. See Attachment B, which includes candidate locations for systemic countermeasure implementation from the Planning Department's Predictive Safety Analysis.

- **Bicycle Parking at Public Schools**: Over the next two years, prioritize funding to upgrade bicycle parking at the following schools: Dr. Ronald A. McNair ES, Glenallen ES, Bells Mills ES, Poolesville ES, Sligo Creek ES, Olney ES, Thomas W. Pyle MS, Silver Spring International MS, North Bethesda MS, Rosa M. Parks MS, Westland MS, Bethesda-Chevy Chase HS, Quince Orchard HS, Walt Whitman HS, and Walter Johnson HS.
- **Bicycle Parking Stations**: Fund a bicycle parking station at the Glenmont Metrorail station.
- Aspen Hill BiPPA: Similar to last year this is still a concern. According to the Aspen Hill Vision Zero Study, there were 23 severe or fatal crashes in the Aspen Hill Vision Zero Study area between 2015 and 2019. Another fatal crash occurred on February 5, 2023 at the intersection of Hewitt Avenue and Georgia Avenue. In 2019, the Planning Board requested the creation of a new BiPPA project to address the deficiencies identified in the Aspen Hill Vision Zero Study, conducted by the Planning Department. ## ADDITIONAL MASTER PLAN ISSUES NOT ADDRESSED IN THE CIP

Some additional master plan transportation issues were identified in the 2023 Travel Monitoring Report regarding protected crossing spacing and building out a grid of streets in Downtowns, Town Centers and along Growth Corridors, consistent with Thrive Montgomery 2050 Growth Corridors section.

- **Protected Crossing Spacing**: The Complete Streets Design Guide identifies protected crossing standards for different street types. Therefore, continued or increased funding support is needed for the Traffic Signals project (CIP Project No P507154) to fill in the gaps in the protected crossing network, including those identified in Table 7 of the 2023 Travel Monitoring Report (see Attachment C).
- **Grid of Streets**: Thrive Montgomery 2050 states that "A more connected street grid is perhaps the single most important step to make our streets safer, more attractive for walking, biking and rolling, and to reconnect communities divided by highways." Therefore, continued support is needed to advance projects in the capital budget to build out the street grid, including:
  - $\circ$   $\;$  North High Street Extended (CIP Project No. P502310) in Olney  $\;$
  - Summit Avenue Extension (CIP Project No. P502311) in Kensington

## **RECOMMENDATIONS/COMMENTS**

Staff is generally supportive of the County Executive's Recommended FY25 Capital Budget and FY25-FY30 CIP, but recommends that the following specific comments be transmitted to the County Council:

- US 29 Pedestrian and Bicycle Improvements (P502304): Increased project funding and an accelerated project schedule should be considered for this project. The current scope of proposed improvements is insufficient to adequately address pedestrian and bicycle needs along the US 29 corridor. As identified in the Bicycle Master Plan Biennial Monitoring Report, potential bikeway connections to the US 29 corridor could be enhanced with the addition of two projects:
  - Castle Boulevard connecting to existing bikeways on Briggs Chaney Road and to the US 29 FLASH station, and
  - **Tech Road/Broadbirch Drive** providing connections to the US 29 FLASH station, Adventist Hospital and the future Viva White Oak development.
- **Montgomery Village Avenue Bikeway:** Design and construct the master-planned bikeway on Montgomery Village Avenue north of the Gaithersburg City line to provide synergies with the coming redevelopment of Lakeforest Mall.
- **Bicycle Parking at Public Schools:** Over the next two years, prioritize funding to upgrade bicycle parking at the following schools: Dr. Ronald A. McNair ES, Glenallen ES, Bells Mills ES, Poolesville ES, Sligo Creek ES, Olney ES, Thomas W. Pyle MS, Silver Spring International MS, North Bethesda MS, Rosa M. Parks MS, Westland MS, Bethesda-Chevy Chase HS, Quince Orchard HS, Walt Whitman HS, and Walter Johnson HS.
- **Systemic Safety Countermeasure Program**: Initiate a funding program focused on systemic improvements that address crash risks identified in the Predictive Safety Analysis.
- **Bicycle Parking Stations:** Fund a bicycle parking station at the Glenmont Metrorail station.
- **Aspen Hill Bicycle-Pedestrian Priority Area project:** Fund a new project to implement the safety recommendations in the Aspen Hill Vision Zero Study.
- **Protected Crossing Spacing:** Continued or increased funding support for the Traffic Signals project (CIP Project No P507154) is needed for the design and construction of more protected crossings to fill in the gaps in the protected crossing network, including those identified in Table 7 of the 2023 Travel Monitoring Report.
- **Grid of Streets:** Continued support is needed to advance projects in the capital budget to build out the street grid, including:
  - North High Street Extended (CIP Project No. P502310) in Olney
  - Summit Avenue Extension (CIP Project No. P502311) in Kensington





## SUMMARY

- Staff recommends transmitting a list of transportation project priorities to the County Executive and County Council for consideration in the FY2025-FY2030 Capital Improvements Program.
- Projects were prioritized based on previous Planning Board prioritization (if applicable), safety considerations, equity considerations, and the bicycle and pedestrian prioritization included in the Planning Board Draft of the Pedestrian Master Plan.
- The prioritization includes 119 projects across nine categories, including 46 bikeway projects, 20 road improvement projects, and nineteen transit projects.

#### **RECOMMENDATIONS SUMMARY**

Planning Staff recommends transmitting the list of transportation project priorities by project category (as shown in Attachment A) to the County Executive and County Council for consideration in the FY2025-FY2030 Capital Improvements Program.

## INTRODUCTION

The County Council adopts a six-year Capital Improvements Program (CIP) every two years in May of even-numbered years. The process of preparing the CIP begins much earlier as county agencies submit CIP requests to the County Executive the prior fall. The County Executive releases his recommended CIP on January 15. During the spring, the County Council reviews the County Executive's request and makes amendments to the CIP before adoption. Transportation funding typically constitutes about one-quarter of the CIP. To help inform development of the six-year CIP, the Planning Board transmits a prioritized list of transportation projects to the County Executive and County Council in the summer of odd-numbered calendar years.

This memorandum provides Planning staff's recommended transportation priorities for the upcoming six-year CIP.

#### **2023 RANKING METHODOLOGY**

The purpose of this process is to provide a way to objectively prioritize different types of transportation projects as to how they best achieve the county's objectives as outlined in Thrive Montgomery 2050, functional, master and sector plans, and other county policy documents, including the Vision Zero Action Plan. This list is intended to be a resource for the county in selecting projects to be included in the CIP. Projects that are expected to be the State's responsibility are also included because the county has contributed significant funds to such projects in recent years. A project is removed from this list once it is either under construction or fully funded and in the Right of Way acquisition process.

New to this review is a modification of how projects are ranked. Previously we ranked a top 100 list of transportation projects. This year we decided to shift the evaluation to rank the projects solely within each category. This allows a more comparative ranking of similar projects using equity focused tools. We included a top ten list within this memo to highlight the projects that we believe to be the most important projects to move forward across all categories.

For this review, the methodology developed in 2021 has been continued and expanded upon as follows:

1) Started with the 2021 Transportation Priorities list as approved by the Planning Board and eliminated projects that were under construction/constructed.

- 2) In a change from 2021, the projects have been sorted into their project Category and then ranked.
- 3) Assigned a weighted Bicycle and Pedestrian Prioritization (BiPPA) score where appropriate to each mappable project and used this score to adjust a project's ranking.
- 4) Included bicycle-related projects from the Bicycle Master Plan Biennial Monitoring Report, 2021-2022.
- 5) Added transportation recommendations from master plans that were approved since the last CIP review in October 2021.
- 6) Adjusted a project's ranking based on how well it addressed the county's Vision Zero goals and the extent to which it would improve safety within the county's High Injury Network (part of the Vision Zero Action Plan).
- 7) Adjusted a project's ranking if it was located in or planned to provide transportation benefits to Equity Focus Areas (EFAs) as designated by Montgomery Planning.
- 8) Adjusted a project's ranking if it addressed the needs/capital improvement implementation plans in an adopted master plan.

## PROJECT EVALUATION

Overall, Planning staff prioritized 119 transportation projects, most of which are recommended in master plans. The projects are prioritized based on an in-depth review of the following factors:

- 2021 Planning Board Ranking
- Safety: Is the project located on the county's High Injury Network (HIN)?
- Equity: Is the project located in an Equity Focus Area (EFA)?
- Bicycle and Pedestrian Priority: The Bicycle and Pedestrian Priority Area score identified in the Planning Board Draft of the Pedestrian Master Plan <u>Appendix</u>.


The overall transportation project rankings by project category are shown in Attachment A.

#### **2021 PLANNING BOARD RANKINGS**

The starting point for the recommended 2023 Planning Board rankings are the 2021 Planning Board rankings.

#### SAFETY CONSIDERATIONS


**Figure 1: High Injury Network**

To assess potential safety benefits of the top transportation priorities, an evaluation was conducted to determine if the proposed project would improve the safety of road segments within Montgomery County's High Injury Network (HIN). The HIN is identified in Montgomery <u>County's Vision Zero 2030</u> Action Plan and includes road segments with five or more severe or fatal collisions per year and one or more collisions per mile per year (excluding interstate highways). The HIN represents 102 road miles, which is only five percent of the county's road network, but most of these road miles are on some of the heavier-traveled state and county-owned non-interstate roads in Montgomery County. Overall, 47 percent of Planning staff's recommended priority projects are expected to provide a safety benefit to roads in the High Injury Network. The High Injury Network is shown in Figure 1.

#### **EQUITY CONSIDERATIONS**

Equity has become a major focus within the Planning Department and is one of the core drivers behind the General Plan update, Thrive Montgomery 2050. Recent transportation planning efforts, including the Pedestrian Master Plan and the Bicycle Master Plan Biennial Monitoring Report, include an equity evaluation. The department's Equity Agenda for Planning ensures that equity is a consideration in all the department's work, and Planning staff will continue to enhance our abilities to address equity concerns and evaluate equity impacts. As part of this biennial review, equity remains a primary consideration in the prioritization of transportation CIP projects.

Equity Focus Areas (EFAs) are parts of Montgomery County that are characterized by high concentrations of lower-income people of color who may also speak English less than very well, as shown in Figure 2. While they represent seven percent of the county's land area, they contain approximately 26 percent of the county's population. By comparison, the top transportation CIP project priorities recommended in this staff report present an improved attention to equity, with 62 percent of the priority projects providing transportation benefits to Equity Focus Areas. This is an increase of 8 percent compared to the 2021 evaluation. This represents only projects that are mappable, so it ignores ongoing programmatic services provided by MCDOT including traffic engineering, RideOn services, streetlighting and others. We will continue to work to improve this transportation CIP evaluation process in future biennial reviews.

Overall, significant effort was expended during the project ranking process to include equity to the fullest extent possible.

#### **BICYCLE AND PEDESTRIAN PRIORITY AREAS**

The Planning Board Draft of the Pedestrian Master Plan uses a data-driven approach to prioritize where pedestrian and bicycle improvements should be made by reimagining the county's Bicycle and Pedestrian Priority Area (BiPPA) program framework. This comprehensively evaluates how BiPPAs are created and prioritized. The Pedestrian Master Plan evaluated discreet geographies throughout the county and assigned a score based on the following criteria: pedestrian activity, bicycle activity, pedestrian crashes, bicyclist crashes, pedestrian pathway comfort, bikeway comfort, pedestrian crossing comfort, bicyclist crossing comfort, equity, school access, and transit access. A more detailed explanation of the Pedestrian Master Plan prioritization scoring can be found in the <u>Prioritization</u> <u>Methodology appendix to the Pedestrian Master Plan. Each project is scored on a scale from generally range from 0 (no priority) to 100 (highest priority). The scores are relative, such that a project with a score of 50 would have twice the priority of a project with a score of 25.</u>

## PRIORITIZATION

Since fiscal capacity limits the county's ability to implement all of the transportation projects identified in master plans, this staff report identifies the top 10 transportation projects overall and the top five transportation projects in each transportation category. All the transportation project rankings by project category are shown in Attachment A. For each project, the following information is provided:

- 2023 Priority Ranking
- 2021 Priority Ranking (if applicable)
- Project Name, Description and Limits
- Relevant Master Plan(s)
- Whether the project is located in an Equity Focus Area
- Whether the project is located in the county's High Injury Network (HIN) and would improve safety
- Bicycle and Pedestrian Priority Area (BiPPA) Score

#### **TOP TRANSPORTATION PROJECTS OVERALL**

Table 1 displays the proposed Top Ten priority projects for all transportation modes. The 2023 overall ranking was informed both by the 2021 ranking (out of 100 transportation projects) and the mode-specific prioritization presented in Attachment A. Following is a summary of the top transportation projects selected:

## Priority #1 – MD 355 Central BRT Priority #2 – Veirs Mill Road BRT

Similar to 2021, two Bus Rapid Transit projects (the MD 355 Central and Veirs Mill Road BRT projects) remain the top two priorities for the county.

#### • Priority #3 – MD 97 (Georgia Avenue)/Montgomery Hills Design Project

The third priority is a Maryland Department of Transportation State Highway Administration (MDOT SHA) project that is now in 75 percent design. Included in this project, is an MDOT SHAproposed bikeway extension from 16<sup>th</sup> Street and MD 97 down 16<sup>th</sup> Street to Spring Street to link up with existing bikeways on Spring Street and to connect to the planned Woodside Purple Line station. This project is included in this list to indicate level of priority, and while it is desired for this project to be funded entirely by MDOT SHA, there are a lot of interconnections with adjacent county-funded projects.

**Priority #4 – Vision Zero Projects** Vision Zero projects continue to require our constant attention and most discrete level of effort work from staff at the Montgomery County Department of Transportation (MCDOT) to implement on a regular basis.

#### • Priority #5 - Level of Effort Sidewalk Retrofit Program

The Pedestrian Master Plan helped to highlight the under-investments of many county streets for pedestrian infrastructure, particularly the need to improve the safety of crossings and to complete or improve connections to schools, parks and transit. While there is an existing CIP project in the Montgomery County CIP budget for minor projects, the funding level is insufficient to serve the demand and/or need.

- **Priority #6 Capital Crescent Trail Tunnel (Woodmont Avenue to Elm Street Park)** The completion of this vital link under Wisconsin Avenue in downtown Bethesda is a critical need to complete the Capital Crescent Trail connection. This project has been a very high priority for the county for many years.
- Priority #7 Montgomery Village Avenue Sidepath between Stewartown Road and the City of Gaithersburg

This sidepath was recently identified during the 2021-2022 Bicycle Monitoring Report as a top equity need within the county. It also will help providing synergies with the coming redevelopment of Lakeforest Mall.

• **Priority #8– Park Trail and Crossings Improvements** CIP funding is also needed to continue to improve existing trails, trail crossings, and provide protected crossings across the county's Park system, where feasible.

# Priority #9 – Aspen Hill BiPPA Enhanced funding and the creation of a separate CIP project for the Aspen Hill BiPPA is recommended. This area was the focus of a Vision Zero study by the Planning Department in 2020.

#### • Priority #10 – Forest Glen Pedestrian Tunnel

The Forest Glen Pedestrian Tunnel is a key safety improvement needed to support the Forest Glen Metro station area, as identified in the 2020 Forest Glen/Montgomery Hills Sector Plan. This project has been subject to funding delays and should be advanced expeditiously.

NOTE: The ranking generally does not include programmatic CIP projects that are ongoing efforts/services provided by the Montgomery County Department of Transportation (including traffic engineering, traffic signal maintenance and operation, streetlighting, and others). A few were included in this list, due to a perceived need to increase the county's level of investment in key bicycle and pedestrian infrastructure.

#### TOP PROJECTS BY TRANSPORTATION CATEGORY

The top transportation project priorities for 2023 represent substantial changes from 2021, with 27 new projects and ten projects removed. The MD 355 BRT project has been split into three parts. These new entries reflect changing priorities from the Bicycle Master Plan Monitoring Report, recently completed master plans and sector plans, and changing county priorities, including an increased emphasis on equity.




Figure 3: Top Transportation Project Priorities by Category

The 119 projects present a wide diversity of transportation projects, fully consistent with current county policies. Figure 3 below shows the breakdown of the 119 transportation priorities by project category. The largest share of projects is the bikeways category (46 projects). The second highest category is road improvements (20 projects) followed closely by transit projects (19 projects). Compared to 2021, the Road Diet and Road Widening categories were merged into a single Road Improvements category. Additionally, Planning staff created the Shared Street category for this 2023 evaluation, so there is no comparison to 2021 available.

The majority of these new entries are bikeway projects, some recommended in recent master or sector plans, while others are being advanced as part of the Bicycle Master Plan Biennial Monitoring Report for equity reasons. It is important to note that some of projects identified above and classified as Bikeway projects include provision of a sidepath which actually serves both pedestrians and bicyclists.

#### **BIKEWAYS**

The top transportation priorities lists include 46 bikeway projects, 12 of which are newly included in the list, as shown in Attachment A. The new projects reflect the Bicycle Master Plan Biennial Monitoring Report, 2021-2022 that the Planning Board reviewed in June 2023, which has recommended focusing on projects located in Equity Focus Areas. The top five projects are displayed in Table 2.

Bicycle projects are typically programmed in three different methods by the Montgomery County Department of Transportation (MCDOT):

- 1) As part of a Bicycle-Pedestrian Priority Area (CIP item)
- 2) As a stand-alone CIP project
- 3) As part of the "Bicycle Program Minor Projects" CIP project (P507596)

Of the 46 bicycle projects identified in the prioritization list, the vast majority are located primarily within BiPPA boundaries of already funded BiPPA CIP projects. The CIP budget, however, may not be adequate to accommodate the addition of these recommended projects. MCDOT should review and seek budget modifications, as necessary.

#### BRIDGES

As shown in Table 3, two bridge projects are identified in the top transportation priorities lists (Attachment A). These projects are critical to expanding the transportation network as recommended in their respective master plans.

#### Protected Crossing Spacing

Table 7 recommends several locations along Thrive Montgomery 2050 Growth Corridors that should be considered for new protected crossings. These locations have some of the highest ratios between the actual distance between protected crossings and the target distance between protected crossings identified in the Complete Streets Design Guide, and many are Equity Focus Areas (EFAs).
