- Section 59.7.3.4.C of the Zoning Ordinance states that the application must be scheduled for a public hearing within 120 days after the date an application is accepted.
- The Application was accepted on September 20, 2023, with an original tentative Planning Board date of January 18, 2024 (120-day expiration on January 18, 2024).
- The Planning Director approved an Administrative 30day extension from January 18, 2024 to February 17, 2024 on December 14, 2023. (The first extension staff report incorrectly reported the extension date as February 15, 2024.)
- The Applicant is requesting a three-month extension of the regulatory review period, which requires the Planning Board to approve. The regulatory extension for the Site Plan review period, from February 17, 2024, to May 18, 2024, is required to adequately address comments from Planning Staff and other agencies.
- Staff supports the Applicant's request to extend the review period with a tentative Planning Board date of May 16, 2024.

On behalf of McDonald's USA, LLC, also known as McDonald's Corporation (the "Applicant"), we are submitting this request for an extension of the review period for the Application. Pursuant to Section 59-7.3.4.C of the Montgomery County Zoning Ordinance, the Montgomery County Planning Board (the "Planning Board") is required to hold a public hearing on a Site Plan application within 120 days of acceptance of the application. With an Application acceptance date of September 22, 2023, the public hearing before the Planning Board would have needed to be held by January 18, 2024. However, the Applicant submitted a request for a 30-day extension of the review period, which was approved administratively on December 14, 2023, and extended the review period until February 17, 2024.
