## Summary

- Section 50.6.3.B of the Subdivision Regulations generally states that an Administrative Subdivision Plan must be acted upon by the Planning Director or scheduled for a public hearing within 90 days after the date of acceptance. The Planning Board may, however, extend this period.
- The Application for Administrative Subdivision Plan No. 620230110 was accepted on September 6, 2023. A Development Review Committee (DRC) meeting was held for this Application on September 26, 2023, with a subsequent resubmittal due on October 11, 2023. The original 90-day regulatory review period expiration was December 5, 2023. On November 30, 2023, the Planning Board approved a four-month extension of the review period to March 28, 2024.
- The Applicant is requesting an additional two (2)
   month extension of the review period to May 23, 2024.
- This extension will allow the Applicant time to address the Forest Conservation Plan and Variance requirements (instead of the forest conservation exemption) and resolve community concerns relating to tree preservation issues.
- The Planning Board hearing on the application may take place before the end of the review period and will be publicly noticed in accordance with the Zoning Ordinance.
- Staff recommends APPROVAL of the extension request.
