Summary

- Section 50.4.1.E of the Subdivision Ordinance generally states that Preliminary Plan applications must be scheduled for a public hearing within 120 days after the acceptance date.
- Preliminary Plan No. 120240080 was accepted on February 7, 2024, which established a Planning Board date no later than June 6, 2024.
- The Applicant requests a four-month extension, which will establish a Planning Board date no later than October 3, 2024. This will allow the Applicant additional time to perform water table testing and corresponding percolation tests required for septic systems.
- Staff recommends APPROVAL of the extension request.
