- Section 50.4.1.E of the Subdivision Regulations generally states that Preliminary Plans must be scheduled for a public hearing within 120 days after the date an application is accepted.
- The Application was accepted on February 7, 2024, which established a Planning Board date no later than June 6, 2024. The Applicant was granted a 30-day extension by the Planning Director, establishing a new Planning Board date not later than July 6, 2024.
- The Applicant is requesting an additional 2-month extension until September 26, 2024 (Attachment A) to address comments and obtain approval letters from MCDPS, MCDOT and MCDPS Fire Access and Water Supply Section.
