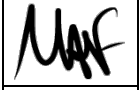

## Summary

- Section 50.6.3.B.4 of the Subdivision Regulations states that the Director must take action on an administrative subdivision plan or schedule a public hearing within 90 days after the date an application is accepted. The Director may postpone the public hearing once, by up to 30 days, without Board approval.
- The Application was accepted on February 7, 2024 with an original 90-day regulatory review period expiration of May 7, 2024.
- The Applicant received administrative approval on May 1, 2024 of a one-month extension of the regulatory review period to June 6, 2024.
- The Applicant is requesting a four-month extension of the regulatory review period, which requires Planning Board approval. The regulatory extension, from June 6, 2024 to October 6, 2024, is required to adequately address comments from Planning Staff and from the community.
- Staff supports the Applicant's request to extend the review period with an expiration of October 6, 2024.
