Summary

- Section 59-D-22.2 of the Zoning Ordinance provides a 90-day review period for Project Plan Hearings. Section 50.4.1.E provides a 120-day review period for Preliminary Plan hearings. Section 59.7.3.4.C of the Zoning Ordinance generally states that a Site Plan application must be scheduled for a public hearing within 120 days after the acceptance date.
- Project Plan Amendment No. 92012004C, Preliminary Plan Amendment No. 12012021D and Site Plan No. 820240100 were accepted on April 17, 2024, which established a Planning Board date no later than August 15, 2024.
- On August 2, 2024, the Director granted a 30-day extension which established a Planning Board date no later than September 12, 2024.
- The Applicant requests a three-month extension, which will establish a Planning Board date no later than December 19, 2024. This will allow the Applicant additional time to work through comments related to site plan design.
- Staff recommends APPROVAL of the extension request.

Our firm represents Black Hill Germantown, LLC, an affiliate of Lerner Enterprises, (the "Applicant") in connection with the above-referenced Preliminary Plan Amendment and Site Plan Applications for the Property located in Germantown, Maryland (the "Property"). On behalf of the Applicant, and pursuant to Montgomery County Code Sections 50.4.1.E and 59-7.3.4.C, we respectfully request an extension of the time in which the Planning Board is required to hold a public hearing on the above referenced Applications. The Applications were initially accepted on April 17, 2024. Accordingly, the 120-day regulatory review period ran through August 15, 2024. Since the Planning Board hearing date fell within the Planning Board's August recess, the Applicant requested a 30-day extension until September 14, 2024, which was granted by the Planning Director on August 2, 2024. The current regulatory review period is set to expire on September 14, 2024.

The Applicant is requesting additional time to work through a few outstanding design comments raised by technical staff. Specifically, the Applicant is requesting a three month extension, which would last until December 14, 2024 and result in a Planning Board hearing no later than December 12, 2024. However, it is the Applicant's intention to work with Staff during the review period so that the full extension period will not be needed.
