#### **REVIEW BASIS**

Chapter 50



- Section 50.4.1.E of the Subdivision Regulations generally states that Preliminary Plans must be scheduled for a public hearing within 120 days after the date an application is accepted.
- The Application was accepted on February 7, 2024, which established a Planning Board date no later than June 6, 2024. The Applicant was granted a 30-day extension by the Planning Director.
- On July 8, 2024, the Planning Board granted the Applicant a 2-month extension until September 26, 2024.
- The Applicant is requesting an additional 2-month extension until November 24, 2024 (Attachment A) to address stormwater management design comments and obtain approval from MCDPS.
- The Planning Board hearing on the application may take place before the end of the review period and will be publicly noticed in accordance with the Zoning Ordinance.
- Staff supports the Applicant's request to extend the review period for two months; however, staff recommends the plan be extended until November 28, 2024.
