Thank you for your call this afternoon. I wanted to follow up with a bit of information regarding The Blairs amendment. As you said, all of the information is on <u>DAIC</u> but a few pertinent documents will share the quick details about the proposal so I have attached those to this email. Dear Paula,

Thank you very much for bring this to the group's attention. As a resident on Roxanna Road, which is one of the closest DC streets to the Blair complex, we already experience the daily impact of inadequate parking and law enforcement resulting from Blair and the other apartments along Eastern Ave. We routinely have Maryland cars parked in front of our house at nights and on weekends whose drivers walk back to apartments on the Maryland side. This brings people

loitering around their parked cars and on our sidewalk, loud pedestrian traffic at all hours, noxious marijuana and cigarette smoke and debris, and litter in our yard. As the mother of teenagers who are driving themselves and coming and going independently, this is especially concerning because my children have had to deal with obnoxious behavior from non-resident drivers while parking our resident-permitted cars on the street, entering and exiting our home, and walking and jogging through our neighborhood.

While I accept that a certain level of this behavior is part of city living, I am concerned that expansion of the use and density of that site, coupled with an even greater deficit of on-site parking for existing and proposed uses, will increase the frequency and severity of these nuisances and potentially result in greater personal safety and property damage issues for our family and the other residents of our neighborhood. As a minimum, any further development on the Blair site <u>must</u> be accompanied by fully adequate on-site parking that will ensure there is no increased parking stress on nearby streets. The Blair owners should not be allowed to extract more profits from the site while burdening nearby residents with the consequences of such development.

In addition, it would cause great environmental harm to pave over the green space that has grown up on the site of the proposed development. The Blair complex is plastered with signage boasting that it is committed to green living, but destroying the open space and wildlife habitat on that parcel and worsening storm water runoff through additional development would prove that their words are nothing more than empty greenwashing. Approving these plans without sufficient protections for neighborhood residents and the environment also would call into question Montgomery County's compliance with its environmental protection standards, especially their commitment to protecting the Chesapeake Bay watershed.

I can't attend the Sept. 24 hearing, but I would be grateful if you would pass my concerns to Montgomery Planning and let us know if there are other steps we can take to voice our concerns.
