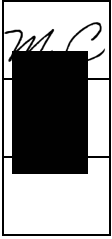

## Summary

- Section 50.6.3.B.4 of the Subdivision Regulations generally states that Administrative Subdivision Plan applications must be scheduled for a public hearing within 90 days after the date of acceptance.
- Application for Administrative Subdivision Plan No. 620240220 was accepted on July 24, 2024, which established a Planning Board date no later than October 22, 2024.
- On October 17, 2024, the Planning Board approved a three (3) month review period extension until January 16, 2025, to allow sufficient time for the applicant to address DRC comments mainly related to driveway access and frontage improvements.
- The Applicant requests an extension of the review period until February 13, 2025. This extension is necessary to allow sufficient time for the applicant to address final comments, and obtain approval letters from outside agencies.
- Staff recommends APPROVAL of the extension request.
