# Summary

- Section 50.6.3.B.4 of the Subdivision Regulations generally states that Administrative Subdivision Plan applications must be scheduled for a public hearing within 90 days after the date of acceptance.
- Application for Administrative Subdivision Plan No. 620240220 was accepted on July 24, 2024, which established a Planning Board date no later than October 22, 2024.
- On October 17, 2024, the Planning Board approved a three (3) month review period extension until January 16, 2025.
- On January 16, 2025, the Planning Board approved a 30-day extension until February 13, 2025.
- The Applicant now requests a three (3) month extension of the review period until May 8, 2025.
- The extension will allow the Applicant time to obtain the necessary agency approval letters.
- Staff recommends APPROVAL of the extension request.
