Summary

- Section 50.4.1.E provides a 120-day review period for Preliminary Plan hearings. The Planning Board may, however, extend this period.
- The Application was accepted on September 18, 2024, which established a Planning Board date no later than January 16, 2025.
- A Development Review Committee (DRC) meeting was held for this Application on October 8, 2024, with a subsequent resubmittal due on October 23, 2024 and a final resubmittal due on November 12, 2024.
- The Applicant requested, and was granted, a 30-day extension by the Planning Director, establishing a new Planning Board date not later than February 13, 2025.
- The Applicant is currently requesting an additional 10-week extension of the review period to March 31, 2025.
- This extension will allow the Applicant time to resolve agency comments related to the submitted stormwater management concept plan.
- The Planning Board hearing on the application may take place before the end of the review period and will be publicly noticed in accordance with the Zoning Ordinance.
- Staff recommends APPROVAL of the extension request.
