Chapter 50



- Section 50.6.3.B.4 of the Subdivision Regulations states that the Director must take action on an administrative subdivision plan or schedule a public hearing within 90 days after the date an application is accepted. The Director may postpone the public hearing once, by up to 30 days, without Board approval.
- The Application was accepted on February 7, 2024 with an original 90-day regulatory review period expiration of May 7, 2024.
- The Applicant received administrative approval on May 1, 2024 of a one-month extension of the regulatory review period to June 6, 2024. The Applicant received a second extension to extend the review period from June 6, 2024 to October 6, 2024. The Applicant received a third extension to extend the review period from October 6, 2024 to February 6, 2025.
- The Applicant is requesting a two-month extension of the regulatory review period, which requires Planning Board approval. The regulatory extension, from February 6, 2025 to April 9, 2025, is required to adequately address comments from the Development Review Committee.
- Staff supports the Applicant's request to extend the review period with an expiration of April 9, 2025.
