Summary

- Section 50.6.3.B.4 of the Subdivision Regulations generally states that Administrative Subdivision Plan applications must be scheduled for a public hearing within 90 days after the date an application is accepted.
- The Application was accepted on April 17, 2024, which established a Planning Board date no later than July 18, 2024. On July 18, 2024, the Planning Board approved an extension to extend the review period to October 24, 2024. On October 16, 2024, the Planning Board approved an extension to extend the review period to January 24, 2025.
- The Applicant requests an extension of the review period to May 22, 2025, to include a Subdivision Waiver of the unplatted parcel requirement in the Applicability Section 50.6.1.A, in addition to revising the drawings to include portable classrooms on the Subject Property.
- The Planning Board hearing on the application may take place before the end of the review period and will be publicly noticed in accordance with the Subdivision Regulations.
- Staff recommends APPROVAL of the extension request.
