- Section 50.6.3.B.4. of the Subdivision Regulations states that the Director must take action on an administrative subdivision plan or schedule a public hearing within 90 days after the date an application is accepted.
- The Application was accepted on September 18, 2024, with a 90-day regulatory review period expiration of December 17, 2024.
- On December 14, 2024, the Planning Director approved a one-month extension of the regulatory review period until January 16, 2025, to address fire access comments.
- The Applicant requests an extension of the regulatory review period until April 17, 2025, to address remaining fire access comments.
- The extension request form erroneously states a March 14, 2025 expiration. The date has been updated to April 17, 2025, as clarified in Attachment B.
- Staff supports the Applicant's request to extend the review period to April 17, 2025.
