Summary

- Section 50.4.1.E provides a 120-day review period for Preliminary Plan hearings. The Planning Board may, however, extend this period.
- The Application was accepted on April 17, 2024, which established a Planning Board date no later than August 15, 2024. The Planning Board approved an extension request establishing a hearing date no later than February 13, 2025.
- The Applicant is requesting an additional threemonth **retroactive** extension of the review period to May 15, 2025.
- This extension will allow the Applicant time to conclude efforts with neighboring property owners to grade and discharge water onto their properties and address outstanding Preliminary Plan DRC comments.
