Summary

- Section 50.6.3.B.4 of the Subdivision Regulations generally states that Administrative Subdivision Plan applications must be scheduled for Director approval within 90 days after the date an application is accepted. The Planning Board may, however, extend this period.
- The Application was accepted on November 27, 2024, which established a Planning Board date no later than February 25, 2025.
