🖹 Summary

- Section 50.6.3.B.4 provides a 90-day review period for Planning Board hearings on Administrative Subdivision applications that include a flag lot or lot without frontage. The Planning Board may, however, extend this period.
- The Application was accepted on August 21, 2024, which established a Planning Board date no later than November 14, 2024. On November 11, 2024, the Planning Board approved a four-month extension of the review period until March 13, 2025.
- The Applicant is requesting a second extension of the review period, for six additional months, until September 11, 2025.
- This extension will allow the Applicant time to address agency comments and resolve issues with agency reviews.
- The Planning Board hearing on the application may take place before the end of the review period and will be publicly noticed in accordance with the Zoning Ordinance.
- Staff recommends APPROVAL of the extension request.
