Summary

- Section 50.4.1.E of the Subdivision Ordinance generally states that Preliminary Plan applications must be scheduled for a public hearing within 120 days after the acceptance date. The Planning Board may, however, extend this period.
- The Application was accepted on May 1, 2024, which established a Planning Board date no later than August 29, 2024. On July 25, 2024, the Planning Board granted an extension of the review period till October 30, 2024. On October 3, 2024 the Planning Board granted another extension of the review period to March 11, 2025.
- The Applicant is requesting an extension of the review period to June 11, 2025.
- This extension will allow the Applicant time to gain an approved Forest Conservation Exemption, gain a water quality plan approval, and address comments from the Development Review Committee.
- The Planning Board hearing on the application may take place before the end of the review period.
- Staff recommends APPROVAL of the extension request
