REVIEW BASIS

Chapter 50



- Section 50.6.3.B.4 of the Subdivision Regulations states that the Director must take action on an administrative subdivision plan or schedule a public hearing within 90 days after the date an application is accepted. The Director may postpone the public hearing once, by up to 30 days, without Board approval.
- The Application was accepted on February 7, 2024 with an original 90-day regulatory review period expiration of May 7, 2024.
- The Applicant received administrative approval on May 1, 2024 for a one-month extension of the regulatory review period to June 6, 2024. The second extension extended the review period to October 6, 2024. A third extension was granted through February 6, 2025. The Applicant received a fourth extension to extend the review period to April 9, 2025.
- The Applicant is now requesting a three-month extension of the regulatory review period, which requires Planning Board approval. The regulatory extension, from April 9, 2025, to July 10, 2025, is required to adequately re-notice the application since it has been pending for more than one year.
- Staff supports the Applicant's request to extend the review period with an expiration of July 10, 2025.
