## 🖹 Summary:

- Section 50.4.1.E of the Subdivision Regulations generally states that a Preliminary Plan application must be scheduled for a public hearing within 120 days after the acceptance date.
- Preliminary Plan Amendment No. 11989156A was accepted on February 3, 2025, which established a Planning Board date no later than June 5, 2025.
- The Applicant requests a time extension, which will establish a Planning Board date no later than November 20, 2025. This will allow the Applicant additional time to resolve comments related to the Final Forest Conservation Plan, and issues related to satisfying open space requirements of the approved subdivision and Plat No. 19448 and Plat No. 19989.
- Staff recommends APPROVAL of the extension request.
