Our firm represents Donohoe Development (the “Applicant”) in connection with the above-referenced Preliminary Plan Application for the Property located at 8800 Brookville Road in Silver Spring, Maryland (the “Property”). On behalf of the Applicant, and pursuant to Montgomery County Code Sections 50.4.1.E and 59-7.3.4.C, we respectfully request an extension of the time in which the Planning Board is required to hold a public hearing on the above referenced Applications. The Application was initially accepted on September 18, 2024. Accordingly, the 120-day regulatory review period for the Applications originally ran through January 17, 2024. The Planning Director granted an initial extension to February 15, 2025. The Planning Board granted extensions to May 31, 2025. In order to provide the Applicant time to continue working on stormwater management arrangements, and to provide Park & Planning Staff additional time to review still pending agency comments related to the stormwater management concept plan, the Applicant is requesting an extension to November 20, 2025.
