- On June 17, 2025, the Planning Director approved a one-month extension of the regulatory review period until August 14, 2025, to address DRC comments.
- The Applicant now requests an extension of the regulatory review period until October 30, 2025, to address remaining DRC comments.
- Staff supports the Applicant's request to extend the review period to October 30, 2025.
