REVIEW BASIS

Chapter 50, Subdivision Regulations



- Section 50.4.1.E. of the Subdivision Regulations states that the Board must schedule a public hearing to begin within 120 days after the date an application is accepted. The Director may postpone the public hearing once, by up to 30 days, without Board approval.
- The Application was accepted on April 11, 2025, with an original 120-day regulatory review period expiration of August 9, 2025.
- On July 3, 2025, the Applicant received Planning Board approval for a two-month extension of the regulatory review period from August 9, 2025, to October 9, 2025, to allow the Applicant to address agency comments and continue coordination with the Parks Department on a concurrent land transfer for a portion of parkland adjacent to the Subject Property.
- The Applicant is requesting a second extension for three-months of the regulatory review period from October 9, 2025, to January 8, 2026. The regulatory extension is needed to continue coordination and address agency comments.
- Staff supports the Applicant's request to extend the review period with a tentative Planning Board date of January 8, 2026.
