Summary

- Section 50.6.3.B.4. provides a 90-day review period for Administrative Subdivision Plans after the date an application is accepted.
- The Application was accepted on October 16, 2024, which established a review period expiring on January 13, 2025.
- The Applicant received an approval for a 30-day extension of the regulatory review period, which required Director-level approval on January 16, 2025. The Applicant received a second approval for a 7-month extension of the regulatory review period from the Planning Board on January 16, 2025. The regulatory review period was extended from February 14, 2025, to September 13, 2025.
- The Applicant is requesting a 6-month extension of the regulatory review period, which requires Planning Board approval. The regulatory extension for the Administrative Subdivision Plan review period from September 13, 2025, to March 12, 2026, is required to adequately address drainage improvements at the frontage of Subject Property and off-site locations.
- The Planning Board approval on the application may take place before the end of the review period.
- Staff recommends APPROVAL of the extension request.
