Summary

- Section 50.4.1.E provides a 120-day review period for Preliminary Plan hearings. The Planning Board may, however, extend this period.
- The Application was accepted on March 12, 2025, which established a Planning Board date no later than July 10, 2025. The Applicant was granted a 30-day extension by the Planning Director, establishing a Planning Board date not later than August 9, 2025.
- The Applicant was granted a second extension for 2months by the Planning Board, establishing a new Planning Board date no later than October 9, 2025.
- The Applicant is requesting an additional 3-month extension of the review period to January 12, 2026.
- This extension will allow the Applicant time to retain land use counsel while addressing Staff comments.
- The Planning Board hearing on the application may take place before the end of the review period and will be publicly noticed in accordance with the Zoning Ordinance.
- Staff recommends APPROVAL of the extension request.
