Summary

- Section 50.4.1.E provides a 120-day review period for Preliminary Plan hearings. However, the Planning Board may extend this period.
- The Application was accepted on April 3, 2024, which established a Planning Board date no later than August 1, 2024.
- The Applicant received a 5-month extension of the review period to January 1, 2025.
- The Applicant received a 3-month extension of the review period from January 2, 2025 to April 3, 2025.
- The Applicant received a 3-month extension of the review period from April 3, 2025 to June 26, 2025.
- The Applicant received a 3-month extension of the review period from June 26, 2025 to September 25, 2025.
- The Applicant is requesting a 4-month extension of the review period from September 25, 2025 to January 29, 2026.
- This extension will allow the Applicant time to obtain an approved Well and Septic Plan from DPS and finalize transportation related cost estimates.
- The Planning Board hearing on the application may take place before the end of the review period and will be publicly noticed in accordance with the Subdivision Regulations.
- Staff recommends APPROVAL of the extension request.
