RESOLUTION FOR REAPPOINTMENT OF ERIN WHITE AS A PUBLIC MEMBER OF THE AUDIT COMMITTEE OF THE MARYLAND-NATIONAL CAPITAL PARK AND PLANNING COMMISSION

WHEREAS, the General Assembly established the Audit Committee of the Maryland-National Capital Park and Planning Commission (the "Commission") by adoption of Subtitle 4, Title 15 of the Land Use Article of the Maryland Annotated Code ("Land Use Article"); and

WHEREAS, among other things, Subtitle 4, Title 15 of the Land Use Article provides in Section 15-402 that the Audit Committee of the Commission (the "Audit Committee") shall have two public members, including one appointed by the Montgomery County Planning Board (the "Board"); and

WHEREAS, upon recommendation of the Chair, by its vote held on December 16, 2021, the Board selected Erin White for initial appointment as a public member of the Audit Committee for a two-year term ending September 30, 2023; and

WHEREAS, upon recommendation of the Chair, by its vote held on October 26, 2023, the Board selected Erin White for reappointment as a public member of the Audit Committee for a two-year term ending September 30, 2025; and

WHEREAS, upon recommendation of the Chair, by its vote held on May 15, 2025, the Board selected Erin White for reappointment as a public member of the Audit Committee for a two-year term ending September 30, 2027; and

WHEREAS, as required by the Land Use Article Section 15-402(f), the Board has given timely notice to the County Council of Montgomery County, by letter dated May 22, 2025, of the pending reappointment of Erin White to remain a voting public member of the Audit Committee and serve for the aforesaid term; and
