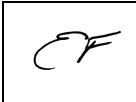

Summary

- Section 50.6.3.B.4. of the Subdivision Regulations states that the Director must take action on an administrative subdivision plan or schedule a public hearing within 90 days after the date an application is accepted.
- The Application was accepted on April 16, 2025, with a 90-day regulatory review period expiration of July 15, 2025.
- On June 17, 2025, the Planning Director approved a one-month extension of the regulatory review period until August 14, 2025.
- On July 21, 2025, the Planning Board approved a second extension through October 30, 2025, to address remaining DRC comments.
- The Applicant is now requesting a 49-day-extension of the regulatory review period, which requires Planning Board approval. This regulatory extension, from October 30, 2025, to December 18, 2025, is requested to make MCDOT’s requested revisions.
- Staff supports the Applicant’s request to extend the review period to December 18, 2025.

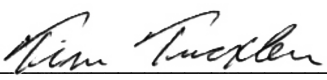
