RE: Special Exception Modification Case No. CBA-1174 Traffic Impact Study (TIS) Holton Arms

Dear Ms. Dwyer:

We have completed our review of Gorove Slade's revised TIS submitted on September 12, 2025. As part of this application, the school proposes a maximum enrollment of 870 students during the school year and a maximum registration capacity of 970 summer campers. The previous approval was for 670 students during the school year and 665 students during the summer.

The subject property fronts the public street maintained by the Maryland State Highway Administration (MDSHA). MCDOT has no jurisdiction other than maintaining and operating the traffic signal, sidewalk, bus stop, bus shelter, or shared-use path along the MDSHA-maintained ROW. Per Montgomery County Code Chapter 50 Section 4.2, MCDOT shall provide recommendations about the ROW maintained by MDSHA, as per the review of the TIS, for the attention of the concerned agencies.

## **TIS Comments**

- All River Road (MD 190) intersections within the studied limits seem to be operating within the
  acceptable levels. We defer to MDSHA for the approval of the traffic analysis for these
  intersections as MDSHA maintains the study intersections. The applicant will be responsible for
  all proposed mitigations listed on Page 22 of the report, which must be approved by MDSHA and
  completed prior to the increase in student enrollment.
- 2. The applicant must install the northbound left turn lane and related improvements on Royal Dominion Drive prior to the increase in student enrollment. At the Montgomery County right-of-

way permit, the applicant must submit detailed drawings for approval by MCDPS for the proposed improvements.

- 3. Before the enrollment cap is increased, the Applicant must install a bus shelter at the existing bus stop along the property frontage on River Road. At the Montgomery County right-of-way permit stage for the northbound left turn lane and related improvements on Royal Dominion Drive, please coordinate with Mr. Wayne Miller at <a href="wayne.miller2@montgomerycountymd.gov">wayne.miller2@montgomerycountymd.gov</a> or at 240-777-5836.
- 4. MNCPPC and MDSHA must approve the Traffic Management Plan before the increase in student enrollment.
- 5. The applicant shall be responsible for relocating utilities, if any, along existing roads to accommodate the applicant's required roadway improvements.

Thank you for the opportunity to review the Fourth (4<sup>th</sup>) TIS Submittal (a Local Area Transportation Report – LATR, Revised TMP and associated materials) prepared by Gorove Slade Associates, Inc., revised October 17, 2025, and submitted via direct e-mail on October 17, 2025, for the Holton Arms School's proposed enrollment increase project (SHA Tracking #24APMO041XX) in Montgomery County, Maryland.

The State Highway Administration (SHA) review is complete, and we are pleased to respond.

- Proposed access to the 670-student school is via one (1) site access to River Road (MD 190).
- The following intersections were analyzed under existing, background and future conditions:
  - o MD 190 intersection with SB I-495 (Outer Loop) Off-Ramp
  - o MD 190 intersection with NB I-495 (Inner Loop) On-Ramp
  - o MD 190 intersection with Burdette Road
  - o MD 190 intersection with Royal Dominion Drive
  - o MD 190 intersection with Beech Tree Road/Nevis Road
  - o MD 190 intersection with Wilson Lane (MD 188)
  - o Burdette Road intersection with Arrowood Road/Hillmead Road
- The report concludes that the recommended mitigation measures significantly reduce queues in the peak direction of commuter traffic flow (westbound) along River Road (MD-190) in the afternoon period
