Summary

- Section 50.4.1.E of the Subdivision Ordinance generally states that Preliminary Plan applications must be scheduled for a public hearing within 120 days after the acceptance date. However, the Planning Board may extend this period.
- The Application was accepted on May 1, 2024, which established a Planning Board date no later than August 29, 2024. On July 25, 2024, the Planning Board granted a review period extension to October 30, 2024. On October 3, 2024, the Planning Board granted a second extension of the review period to March 11, 2025. On March 6, 2025, a third extension was granted by the Planning Board to June 11, 2025. On June 5, 2025, a fourth extension was granted to November 13, 2025.
- The Applicant is requesting a fifth extension of the review period to January 6, 2026 to revise drawings and obtain an approval letter from MCDOT and environmental staff approval.
- The Planning Board hearing on the application may take place before the end of the review period.
- Staff recommends APPROVAL of the extension request.
