 2025, which established a Planning Board date no later than June 5, 2025.
- On May 26, 2025, the Planning Board granted a time extension until November 20, 2025.
- The Applicant requests a time extension, which will establish a Planning Board date no later than April 23, 2026. This will allow the Applicant additional time to resolve staff comments related to ownership and the requirements of the approved subdivision and Plat No. 19448 and Plat No. 19989.
