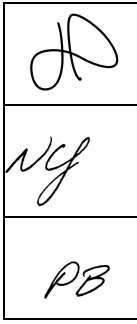

Summary

- Section 50.6.3.B.4. of the Subdivision Regulations states that the Director must take action on an administrative subdivision plan or schedule a public hearing within 90 days after the date an application is accepted.

- The Applicant requests an extension of the regulatory review period until March 30, 2026, to address remaining DRC comments from Planning Staff and County Agencies.
