

Summary

- Section 59.7.3.4.C provides a 120-day review period for Site Plan reviews. The Planning Board may, however, extend this period.
- The Application was accepted on August 1, 2025, which established a review period that ended on November 29, 2025. The Applicant was granted a 30-day extension by the Planning Director, establishing a review period ending on December 29, 2025.
- The Application is a Minor Site Plan Amendment and does not require a Planning Board hearing.
- The Applicant is requesting an additional 3-month extension of the review period to March 29, 2026.
- This extension will allow the Applicant time to address Stormwater Management (SWM) comments and investigate hidden/concealed utility lines that may impact SWM layout and potentially the tot lot area.
- The Planning Board hearing on the application may take place before the end of the review period and will be publicly noticed in accordance with the Zoning Ordinance.
- Staff recommends APPROVAL of the extension request.
