## Summary

- Section 50.6.3.B.4 of the Subdivision Regulations generally states that Administrative Subdivision Plan applications must be scheduled for Director approval within 90 days after the date an application is accepted. The Planning Board may, however, extend this period.
- The Application was accepted on November 27, 2024, which established a Planning Board date no later than February 25, 2025. Due to drought conditions during water table testing season a septic test was not possible, prompting an extension to July 24, 2025. A subsequent extension until December 18, 2025, was granted to allow additional time to schedule a septic test appointment.
- The Applicant is requesting an additional 6-month extension of the review period until June 18, 2025, to allow the septic excavator to conduct additional septic testing.
- The Planning Board hearing on the application may take place before the end of the review period and will be publicly noticed in accordance with the Zoning Ordinance.
- Staff recommends APPROVAL of the extension request.


