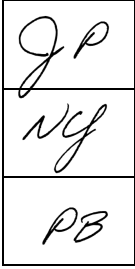

Chapter 22 & Chapter 59

Summary

- Section 50.4.1.E of the Subdivision Ordinance generally states that Preliminary Plan applications must be scheduled for a public hearing within 120 days after the acceptance date. The Planning Board may, however, extend this period.
- The Application was accepted on March 18, 2025 and received 3 previous extensions, which established a Planning Board date no later than April 9, 2026.
- The Applicant is requesting an extension of the review period to May 21, 2026. This extension will allow the Applicant time to coordinate the pressure sewer system and concept stormwater management plan for the development.
- The Planning Board hearing on the application may take place before the end of the review period.
- Staff recommends APPROVAL of the extension request.
