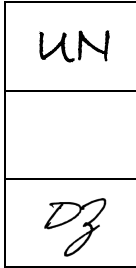

## Summary

- Section 50.4.1.E of the Subdivision Ordinance generally states that Preliminary Plan applications must be scheduled for a public hearing within 120 days after the acceptance date. However, the Planning Board may extend this period.
- The Application was accepted on May 1, 2024, which established a Planning Board date no later than August 29, 2024. On July 25, 2024, the Planning Board granted an extension of the review period until October 30, 2024. On October 3, 2024, the Planning Board granted a second extension of the review period to March 11, 2025. On March 6, 2025, the Planning Board granted a third extension to June 11, 2025. On June 5, 2025, a fourth extension was granted until November 13, 2025. On that date, a sixth extension was provided to January 6, 2026, before a Director level extension was granted on February 2, 2026. On February 5, 2026, a seventh extension was approved to move the expiration date to May 7, 2026.
- The Applicant is requesting an eighth extension of the review period until September 10, 2026, to revise drawings and obtain an approval letter from Montgomery County Department of Transportation (MCDOT).
- The Planning Board hearing on this application may take place before the end of the review period.
- Staff recommends APPROVAL of the extension request.
